TERMS AND CONDITIONS

1. Qualifying seed must be purchased between September 6, 2023 and November 15, 2023, together with the in-crop herbicide, at the program price, as outlined by Richardson Pioneer, to be eligible to receive Richardson Rewards under PERFORMANCE, PERFORMANCE PLUS, and PERFORMANCE PRO tiers. Not all purchases of seed are eligible to receive Richardson Rewards.
2. Eligible growers must elect their Richardson Reward in relation to qualifying seed purchases as either a crop input credit with Richardson Pioneer or as a Richardson Pioneer grain premium by November 15, 2023. Growers who do not make an election by the applicable date will receive the Richardson Rewards as a crop input credit.
3. Richardson Rewards will be granted to the customer making the qualifying purchases as a crop input credit with Richardson Pioneer on the customer's account or (if the election is made for the qualifying seed and in-crop herbicide purchase) as a Richardson Pioneer grain premium.
4. Additional level PERFORMANCE PLUS and PERFORMANCE PRO Rewards are available exclusively as crop input credits with Richardson Pioneer and are not eligible for grain premium elections.
5. Richardson Rewards are non-transferable and may not be redeemed for cash payment.
6. Richardson Rewards for crop input purchases will be awarded based on purchases made from Richardson Pioneer between September 1, 2023 and July 31, 2024. Credit will be available to use for crop input purchases made after September 1, 2024.
7. Richardson Rewards grain premium may be used on new grain contracts made between October 31, 2023 and July 31, 2024. Grain contracts must specify a delivery period expiring not later than December 31, 2024. If a grain contract is not entered into before July 31, 2024, the grain premium reward will expire and no payment or credit will be made to the grower.
8. Grain premiums (if elected) which refer to \$2.00/acre will be calculated on the basis of a maximum of 0.2mt/acre, and those which refer to \$3.00/acre will be calculated on the basis of a maximum of 0.3mt/acre for qualifying acres (that is, the grain premium will be applied as \$10.00 per metric tonne).
9. Rewards calculated on a per acre basis will be assessed based on recommended application rates for the applicable crop input product. If PERFORMANCE PLUS or PERFORMANCE PRO purchases are made for less than the total number of acres for which qualifying seed and in-crop herbicide is purchased, Richardson Rewards will be granted only for those acres in relation to which such crop inputs were purchased. Rewards will not be granted for PERFORMANCE PLUS or PERFORMANCE PRO acres in excess of the acres applicable to the qualifying seed and in-crop herbicide.
10. Richardson Rewards and qualifying purchases are available only for crop input purchases and grain deliveries in the Richardson Pioneer qualifying jurisdictions of British Columbia, Alberta, Saskatchewan and Manitoba.
